

Cookies policy

Denuo LLC (OGRN 1227700120867, INN 9710096279) uses cookies on its website https://denuo.legal/ ("Website") in accordance with its Cookies Policy and Confidentiality Policy.

1. What are cookies and what do we use them for?

Cookies are small text files placed on the hard drives of your device (computer, laptop, smartphone or tablet) when you visit a website. Cookies are designed to improve the performance of websites and help website owners collect information about your preferences. Each time you visit our Website, your browser sends a cookie to the Website to help recognise the user's device and optimise Website navigation for each subsequent visit to the Website.

The use of cookies is now standard practice for most websites. Most browsers allow you to view and manage cookies or refuse cookies and delete them from your device's hard drive.

2. How long do cookies stay on your device?

We only use the information contained in cookies for the purposes stated above. The data collected will be stored on your device for a period which may vary depending on the type of cookie concerned, but no longer than it is necessary to achieve the purpose stated above, following which the files will be automatically deleted from your system. We remind you that, depending on the browser you use, you can always delete cookies from your device's hard drive yourself.

During your visit to the Website you may be asked for your consent to the use of cookies. If, after you approve the use of cookies, you change your mind, you can do so by deleting the cookies stored in your browser. As a rule, to withdraw your previous consent, you need to make changes to the settings of the browser you are using (please refer to the browser manual or its developer's website). After you withdraw your consent, the Website may once again display a pop-up window asking for your consent and you may be able to make a different choice. You can also change your browser settings to accept or reject all cookies or cookies from certain websites by default.

If you reject technical cookies, certain content or features of the Website may become unavailable or may not operate properly.

3. What cookies do we collect?

The Website collects the following types of cookies:

- session cookies (which are deleted automatically when the session ends, i.e., after the Website is closed);
- permanent cookies (which are stored in the user's browser after the session ends, i.e., they are not deleted when the Website is closed).

Types and functions of cookies:

- Technical cookies are necessary to enable proper operation of certain areas (pages) of the Website. They
 also help balance server load, collect information on the user's cookie preferences, etc. This type
 of cookies includes session and permanent cookies. Without these files, the Website does not function
 properly or does not work at all.
- Analytics cookies are designed to collect information on the visitors' use of the Website. Such information is needed to report on and improve the Website operation, make it more user-friendly and monitor the Website's effectiveness. This type of cookies collects depersonalised information about visitors' actions on the Website, i.e., the pages they have viewed, information about where website visitors are from, etc. Analytical cookies may be installed by the Website or by third-party domains.
